

Terms & Conditions for iVisaPoint Cash Referral Bonus

- Information on how to enter and prizes form part of these terms and conditions.
 Entry into the <u>iVisaPoint Cash Referral Bonus</u> (the Promotion) is deemed to be an acceptance of the following terms and conditions. Entries must comply with these conditions to be valid.
- 2. **Who can enter?** Entry is open to anyone over the age of <u>18 years</u>. The Promoter's management, employees and their immediate families are ineligible to enter.
- 3. **Promotion Period**: The Promotional period is ongoing however management reserves the right to cease this promotion at any time.
- 4. **How to be eligible?** To enter the Promotion, an entrant must, during the Promotion Period:
 - a) Refer iVisaPoint to any of their friends or family;
 - b) This referred client must mention the details of the referrer FIRST and then request and complete a service with iVisaPoint valued at a minimum of \$500 AUD. - 7. **Referrer**: Where requested by the Promoter, the referrer must provide evidence which, to the reasonable satisfaction of the Promoter, demonstrates that he or she

- is the referrer, has provided a referral and has complied with these terms and conditions.
- 8. **Disqualification**: The Promoter reserves the right to verify the validity of any referrer and to disqualify any referrer who forged, manipulated or tampered with the referral process, who submits a referral that is not in accordance with these terms and conditions or who provides false information, where applicable.
- 9. **Claiming prizes:** All winners are to attend the iVisaPoint office to claim their prize at their own cost. Unless agreed upon otherwise, it is the sole responsibility of winners to claim their prize. The Promoter will not remind the winners.

Liability and release: The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury, loss or damage suffered or sustained (even caused by negligence) in connection with accepting or using the prize or participating in this Promotion, except for any liability which cannot be excluded by law.
